



Welcome to ElectricAid's 2017 Annual Report! In 2017, ElectricAid through your generosity once again improved the lives of thousands of people worldwide, spending €1.18 million and funding some 154 separate development and relief projects, some in Ireland but primarily across the Developing World.

ElectricAid is primarily engaged in development funding rather than disaster alleviation. However, with our roots in the Ethiopian famine of the 1980s, we do not turn our back on emergencies and humanitarian appeals. In 2017, we held a Special Appeal for the East Africa Food Crisis affecting up to 40 million people in about 7 different countries, and the Biblical monsoon flooding in South Asia severely impacting another 25 million people. ElectricAid committed €76,000 to this emergency throughout 2017, driving life-giving humanitarian responses across both regions. This would not have been possible without the steadfast and generous response of our members, supporters and friends, including ESB and EirGrid. €21,000 of the funds committed to this Special Appeal came from the proceeds of our "Leaving Fitzwilliam" online staff auction, once again we thank ESB for their kind generosity in donating the auction items.

2017 was a steady year for ElectricAid. Income increased by 5% from €1.13 million in 2016 to €1.19 million in 2017, this is a "once-off" gain, arising from member's extraordinary generous response to our Special Appeal. Membership unfortunately decreased by 1.5% to 2,464 members. It is critical that ElectricAid's membership and income is maintained or increased in 2018 as the needs of the poorest and most disadvantaged around the world have never been greater. This objective is being addressed by a number of planned recruitment campaigns across ESB.

Great progress was made on the 2017 Business Plan which focussed on improving ElectricAid's governance, data protection and the documentation of processes and procedures. The 2018 Business Plan will focus on governance, data protection and planned recruitment campaigns.

The General Data Protection Regulation (GDPR), which comes into force on 25th May 2018, will impact significantly on our communications with our members. GDPR increases the obligations on all organisations to handle personal data appropriately and carefully, it increases individual rights to privacy, and to having personal data used only for purposes to which the individual has agreed. A GDPR sub-group was set up in 2017 to put an action plan in place to ensure ElectricAid's compliance with GDPR.

As a key part of our governance and risk management process, we carry out annual desk audits and site audits of funded projects across the globe. Desk audits are carried out by each Committee Member annually. Site audits pose more of a challenge to ElectricAid as the projects we have funded are all over the world. In 2017, we had 11 projects in Ireland, Tanzania and Uganda visited on our behalf by members. These visits are hugely useful for ElectricAid, and are very often a really rewarding experience for the visitor. Members can see at first hand the projects ElectricAid is funding. If you, or somebody you know, are travelling to a developing country (particularly in Africa, Asia, and Central or South America), and would be interested in visiting an ElectricAid project, then please do get in touch with us, we would be delighted to hear from you.

We do our utmost to keep you updated on development news and the work that ElectricAid is doing across the globe. Our website www. electricaid.ie has become a fantastic and effective platform to update and communicate with all of our members, supporters and partners. Please visit the site often and use the 'Follow Us' option.

I have decided to step down as Chairperson after 3 rewarding and fruitful years in the position. It has been a pleasure to chair on your behalf and I wish my successor, Éadaoin Smith, all the best in her new role. I should like to express my thanks to a number of groups/individuals for their outstanding contribution in helping those in need over the last year.

• James Foley, our ElectricAid Office Manager, is retiring in May 2018. James has been at the heart of ElectricAid for the last 14 years and has a sincere passion for the work ElectricAid does. Week on week, through James' communications he has brought ElectricAid's work to life, keeping awareness alive and interest high. James' unique range of talents, hand in hand with his consistent hard work and commitment has been an invaluable asset to ElectricAid. His great sense of humour, friendship,





energy and unyielding passion will be greatly missed by all of us. We wish James a fulfilling and well-earned retirement and every success in his new adventure ahead.

- I would also like to thank *Alex Dalton*, our placement student in 2017, for his refreshing commitment and positive attitude. We wish him all the best in his final year in NCI.

It is this partnership and support from members, supporters, ESB and EirGrid that enables ElectricAid to be effective in making a difference - helping the poorest people in the world to help themselves. We couldn't do it without you!

AN APPEALING YEAR -A RESPONSIVE YEAR.

One of the features of 2017 was the variety and success of our appeals and fundraisers. Success here flows directly from the open-hearted response of the ElectricAid community – members, supporters, friends, companies. This response is reliably generous, but never taken for granted. ElectricAid had already committed €20,000 from our own resources to the developing situation in East Africa, when we launched our own *Special Appeal for East Africa & South Asia*, at a time when neither disaster had the oxygen of world publicity. At the time, it seemed that the latest tweets of Donald Trump were more important than the slow-moving food emergency in East Africa, and that the flooding of Houston was more photogenic & pressing than the continental-scale misery in South Asia. Despite this, the ElectricAid family came through again with a remarkable €61,500. *The following table tells you exactly where that money went:*

Our most novel fundraiser was our "Leaving Fitzwilliam" online auction of furniture, prints and bric-a-brac from 27 Lr. Fitzwilliam Street, kindly donated by ESB. The auction, confined to ESB serving staff members, necessitated the development of a full catalogue and an online auction site on Sharepoint. We received enormous help and goodwill from a variety of sources, with the contribution of Facilities and ITS, and the huge input and energy of Alex Dalton, our placement student, carrying this complex project to great success. The auction and aftermath were very enjoyable as well as successful, with hundreds of people all over ESB developing "auction fever", and picking up many bargains and real mementos of ESB's old and much-loved HQ. We smashed through our initial target of €10,000, raising a remarkable total of €22,000. To underline the gravity of the East Africa situation, we immediately committed these funds directly to that cause.

Finally, to perhaps the most gratifying of all our initiatives – the *ElectricAid "Water Bucket" Appeal* in December, which focused on Irish Water refund cheques. The idea was based on the notion that the ElectricAid community was likely to see the value of a national utility delivering a critical service, and would be uneasy about receiving these refunds. This simple appeal, which promised to devote all funds received to WASH (Water, Sanitation & Hygiene) projects in the Developing World, really struck a chord with our supporters, and within a few weeks raised a really heart-warming total of €20,600. This appeal straddled 2017 and 2018, so not all the funds raised are reflected in the 2017 accounts presented here today. However, I can cheerfully report that all funds received are now hard at work bringing clean water to 7 communities in in Uganda, Kenya, Mozambique and Togo.

The ideas were good, but it's important to state once again that it is only the generosity of the entire ElectricAid community that makes these appeals successful, and which has reached out to so many people in despair. **Thank you all.**





OVERHEADS& EFFICIENCY

My report last year focused on overheads and expenses (or the lack of them!) in ElectricAid. It has to be said at the outset that it costs money to run any charity, and that the idea of an overhead-free charity is largely a fantasy. However, ElectricAid is in the very privileged position that our overheads are generously picked up by ESB. Last year, I featured our performance in devoting 99.5% of funds received on projects, as compared with 92% and 93% for two other world-class NGOs.


I am delighted to report that we have even improved on that performance in 2017. Our bank charges and miscellaneous costs have reduced to €1,500 from €5,400 in 2016. These costs are now only 0.13% of our expenditure - 99.87% of funds "get there". This is a world-leading performance, and offers real reassurance in an area that I know causes some concern to potential donors.

On top of the foregoing, ElectricAid does not fund overhead or expenses for the projects or NGOs that we fund. So the reassurance is two-fold – that all of your money gets there, and that when it gets there it is only devoted to real grass-roots development project funding.

INCOME

Our income model is strong and sustainable – the three main pillars are members' subscriptions, ESB and EirGrid match funding, and Revenue tax rebates. It's on this stable three-legged stool that ElectricAid's finances sit. Our tax rebate income fell in 2017, due to the lack of a large-scale Special Appeal in 2016, but our overall income grew by 5% to €1.185 million – a highly satisfactory outcome.

Your charity is in a very stable financial position, professionally managed and with an excellent Executive Committee. Special mention should go to our highly-efficient Treasurer, Hilary Boyse. Hilary has the gift of clarity in financial matters, and she robustly exercises her financial control function, so that we don't go off any rails in spending your money.

MEMBERSHIP

If there is a disappointing aspect to 2017, it lies here. Our slow growth in membership came to a disappointing end in 2017, with a 1.5% fall to 2,464 members. This is by no means a huge decline, and the 5-year trend is still upwards. It does underline again the need to continue focused recruitment efforts amongst the serving staff.

Recruitment efforts do work; last year, as a result of a series of focused events in EirGrid, we picked up new members and increased EirGrid membership by 18%. The challenge is to replicate something like this in ESB in 2018 and beyond.

Managing ElectricAid, and building the ElectricAid community, is about communications, in so many different ways. A simple "thank-you" card can make a big difference to new member or once-off donor. Keeping our membership upto-date via the Hub, Staff Notice Board, Yammer and EirGrid media is an ongoing task, and one which we do well. Additionally, I always treat the Annual Report as a critical communications and recruitment tool.



A feature of 2017 has been the continuing growth and success of our own external internet site, **www.electricaid.ie**. The site is now in its 4th year, and is going from strength to strength. Developed in-house and voluntarily, at no cost to ElectricAid, primarily by Anthony Le Courriard and Pearse Crilly, who is stepping down from the Committee after a decade of remarkable service. Our hosting fee with WordPress is the princely sum of €99 per annum.









PROJECT & RELIEF FUNDING

ElectricAid continues to support projects both at home and all over the Developing World. This work would not be possible without the steadfast support and immense generosity of our donors, however success in membership and revenue growth only obtains real meaning when you consider what is done, and the results obtained, with your money. The accompanying list of each and every ElectricAid funding in 2017 is the true heart of this report.

We funded a massive total of 154 Development & Relief Projects, in Ireland and all over the Global South, with a total of €1.18 million.

Every funding is detailed. What should also be apparent are the tens of thousands of lives that your generosity has touched, improved, developed, and (in some cases) saved over the year. Your money went on grass-roots development, achieving fantastic results with relatively-small amounts of well-targeted funding. In education, infrastructure, health care, agriculture and livelihoods, you are making huge differences to thousands of real lives. The ElectricAid community (for we are just custodians of your generosity) reaches out, and improves the world.



THANKS!

Every year, I thank the "usual suspects" – although they are only "usual" because of their unending support and co-operation. You know who you are, please consider yourselves thanked!

This year is slightly different, as I will be retiring from ESB and from the management of ElectricAid at the end of May 2018. I should also salute the fantastic people I've met in the NGO partner organisations. Some of them have been truly inspirational – I'll mention just one. "Sister/Doctor" Maura Lynch, Medical Missionaries of Mary who spent a lifetime in Angola and Uganda working for the poor, the sick and the dispossessed. She ended up as Chief Surgeon of Kitovu Hospital in Uganda, and a world authority on the surgical treatment of Obstetric Fistula. She "died with her boots on" in Uganda in 2017, in her 80th year, with no notion of retirement to a life more ordinary. It was a privilege to support her work, and that of so many other remarkable people.

Finally, ElectricAid is nothing without its members.


2,500 of you voluntarily put your hands in your pockets to help the poorest of the poor – people you will never know.

COMMITTEE MEMBERS REPORT FOR THE YEAR ENDED 31ST DECEMBER 2017

The executive committee present their report along with the financial statements of the charity for the year ended 31st December 2017. The financial statements have been prepared in accordance with the accounting policies set out in note 2 to the accounts and comply with the charity's constitution, Section 207 of the Taxes Consolidated Act 1997, the Charities Act 1961 to 1973 and the Statement of Recommended Practice, applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1st January 2015).

Structure, Governance and Management

The executive committee and the trustee's who held office during the financial year and at the date of this report are set out on the information page.

Trustees

- Five Trustees shall control the funds of the Scheme and make the disbursements authorised by the Executive Committee.

Appointment as a Trustee shall be for a period of three years only and shall be renewable at the end of each such period. Officers or members of the Executive Committee shall not be eligible for appointment as Trustees. Two of the Trustees shall be elected at each third Annual General Meeting of the Scheme. The Chief Executive of the ESB shall nominate two Trustees as soon as practicable after the members have elected their two Trustees. The Chief Executive of EirGrid may nominate one Trustee as soon as practicable after the members have elected their Trustees.

An elected Trustee may retire by written resignation or shall automatically retire if required to do so by a decision of the members attending an Annual General Meeting or an Extraordinary General Meeting. The Chief Executive of the ESB may revoke the appointment of a nominated Trustee at any time. The remaining Trustees shall fill any casual vacancy arising among the elected Trustees by co-option of a member of the Scheme. A co-opted Trustee shall hold office for the remainder of the term of office of the Trustee being replaced. A casual vacancy among the nominated Trustees shall be filled by a person nominated by the Chief Executive of the ESB to hold office for the remainder of the term of office of the person being replaced.

The Trustee shall not be liable to make good any deficiency in the funds of the Scheme but shall be liable only for such sums of money as shall be actually received by them on account of the Scheme.

Executive Committee

- Administration of the Scheme shall be carried out by the Executive Committee, which shall comprise: Honorary Officers, Chairperson, Vice Chairperson, Honorary Secretary and Honorary Treasurer, elected by the members and at least six and not more than ten members elected by the membership at the AGM.

The Executive Committee shall meet as necessary for the administration of the Scheme but in any event the Executive Committee shall meet not less than four times per annum. A notice of the meeting and agenda shall be sent to every member of the committee. A quorum for every meeting shall be half of the committee members. In the absence of the Chairperson and Vice Chairperson one of the other committee members shall, by agreement, chair the meeting. For the purpose of voting at meetings all members shall have a vote and in the case of a tie the person chairing the meeting shall have a casting vote. Decisions taken at meetings will be on simple majority basis. Any vacancies that arise in the committee will be filled by co-opting by the committee. Such co-options may have regard to the executive election at the previous AGM. Requests for aid (with the exception of requests for emergency relief aid) must be submitted to the Honorary Secretary at least a week in advance of any meeting. Requests may be made by any recognized charitable organisation or agency, or by a member of the Scheme on behalf of such organisation or agency. For the purpose of advancing the objects of Electricaid, sub committees may be set up by the Executive Committee. The powers and rules of procedure of such sub committees will be at the discretion of the Executive Committee at all times.

Risk Management

The charity executive committee have considered the major risks to which the charity is exposed and have reviewed those risks and established systems and procedures to manage those risks.

Objectives and Activities

The main object for which the charity is established is to raise money for the relief of want and to assist the needy at home and abroad, provided always that the income of the charity shall be applied solely for charitable purposes within the meaning of Section 207 of the Taxes Consolidation Act 1997.

Grant Making Policy

The Executive Committee shall authorise the disbursement of monies to such projects or agencies as are, in the opinion of the committee, consistent with the main object of the Scheme. Notwithstanding any other provision herein, emergency relief aid consistent with the main object of the Scheme may be disbursed without the necessity to hold a meeting of the Executive Committee provided that the prior agreement of half of the committee members (including the Treasurer and the Chairperson or in his or her absence the Vice Chairperson) is obtained thereto. A copy of each disbursement authorisation shall be provided to each of the Trustees.

Financial Review

The charity is reliant on the following sources of income, the ESB staff / pension payroll donations, Eirgrid staff donations, the ESB board and the taxation rebate received from the Revenue Commissioners. Total income for 2017 was €1,183,081 compared to income of €1,124,855 in 2016. There was a surplus of income in the current year €11,273 (deficit in 31 December 2016 €26,759). As at 31st December 2017 the charity had reserves to carry forward in to sum of €357,628.

Investment Policy and Performance

The charity does not hold sufficient monetary reserves to generate additional income through investments. All monies are held in a current account controlled by the trustee's with the principal banker.

Reserves Policy

ElectricAid hold a reserve balance of €357,628 at 31st December 2017. This is to ensure, as far as is reasonably possible, that the charity's future expenditure objectives can be met, given certain assumptions made about future income streams. The 2017 Business Plan also identified a requirement that ElectricAid should maintain a capability of €50,000 for immediate emergency response in the event of a major humanitarian disaster. These funds would, if expended, be recouped from the proceeds of a Special Appeal.

Future Plans

While enormous progress has been made in the last 20 years in achieving the Millennium Development Goals, the needs of the poorest and most disadvantaged around the world have never been greater. The ElectricAid Committee will continue to address poverty and development needs in the Developing World, social need in Ireland, and contribute to the relief of poverty and emergencies at home and abroad.

In the Developing World, we aim for long-term and environmentally sustainable improvement in the well-being of communities and we will continue to focus on micro-development projects in the areas of education, basic infrastructure and sanitation, health needs, food security, energy and micro enterprise. We will continue to promote awareness within the Electricity Supply Board and Eirgrid of development issues. In partnership and support from our members, ESB and EirGrid, we plan to continue and strengthen our commitment to the struggle against global poverty and for sustainable development, world-wide.

COMMITTEE MEMBERS RESPONSIBILITIES FOR THE YEAR ENDED 31ST DECEMBER 2017

Executive Committee Responsibilities

The constitution of the charity requires the executive committee to prepare audited financial statements for the financial year which give a true and fair view of the charity's financial activities during the year and of its financial position at the end of the year. In preparing these financial statements giving a true and fair view the executive committee should follow best practice and:

Nyayiah Maker and her six month old son Nya Ban Nyieny at Duong Health Clinic outside Nyal. She has five children and her eldest is seven-years-old. Nyayiah came from Leer, where there was no clinic, and has family here. Her son had the worst malnutrition reading of the day. His mid-upper arm circumference was 9cm, about the same as that of an adult's index and middle fingers. The clinic treats all kinds of injuries and illnesses but most commonly diarrhoea, malaria, bilharzia & malnutrition. Infants and young children are screened using colour coded tapes to measure their Mid Upper Arm Circumference (MUAC) and if this is under 11cm / red then they are likely to have Severe Acute Malnutrition but this is double checked by taking height and weight measures and comparing them to average figures for the child's age.

1. General Information

ElectricAid is the Association domiciled in Ireland. The registered office and its place of business is 27 Lower Fitzwilliam Street, Dublin 2.

Statement of Compliance

These financial statements have been prepared in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" ("FRS 102"). Currency

The financial statements are prepared in Euros, which is the functional currency of the company. Monetary amounts in these financial statements are rounded to the nearest €.

2. Statement of accounting policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the charity's financial statements.

2.1. Basis of preparation

The financial statements have been prepared in accordance with the charity's constitution, Section 207 of the Taxes Consolidated Act 1997, the Charities Act 1961 to 1973 and the Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Practice applicable in the UK and Republic of Ireland (FRS 102) (effective 1st January 2015). The audited financial statements are prepared under the historical cost convention and in accordance with applicable accounting standards.

2.2. Fund Accounting

Unrestricted funds are general funds that are available for use at the executive committees' discretion in furtherance of the objectives of the charity.

Designated funds are unrestricted funds set aside at the discretion of the executive committees for specific purposes. The designated fund for fixed assets is that part of unrestricted funds that represents fixed assets held.

Restricted funds are those donated for use in a particular area or for specific purposes, the use of which is restricted to that area or purpose.

2.3. Donations and legacies

Voluntary income, including donations, gifts and legacies and grants that provide core funding or are of a general nature, are recognised once the charity has entitlement to the resources, it is certain that the resources will be received and the monetary value of incoming resources can be measured with sufficient reliability.

2.4. Expenditure on charitable activities

Expenditure is recognised as resources expended as soon as there is a legal or constructive obligation committing the charity to the expenditure. All expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category. Costs of generating funds are those costs incurred in attracting voluntary income, and those incurred in trading activities that raise funds.

Governance costs include those incurred in the governance of its assets and are primarily associated with constitutional and statutory requirements.

3. Income

The total income of the charity for the year represents donations received from employees/pensioners from ESB/Eirgrid. ESB/Eirgrid also commit to a capped matching fund on an annual basis depending on the donations of their employees/pensioners. All income arises within the state.
