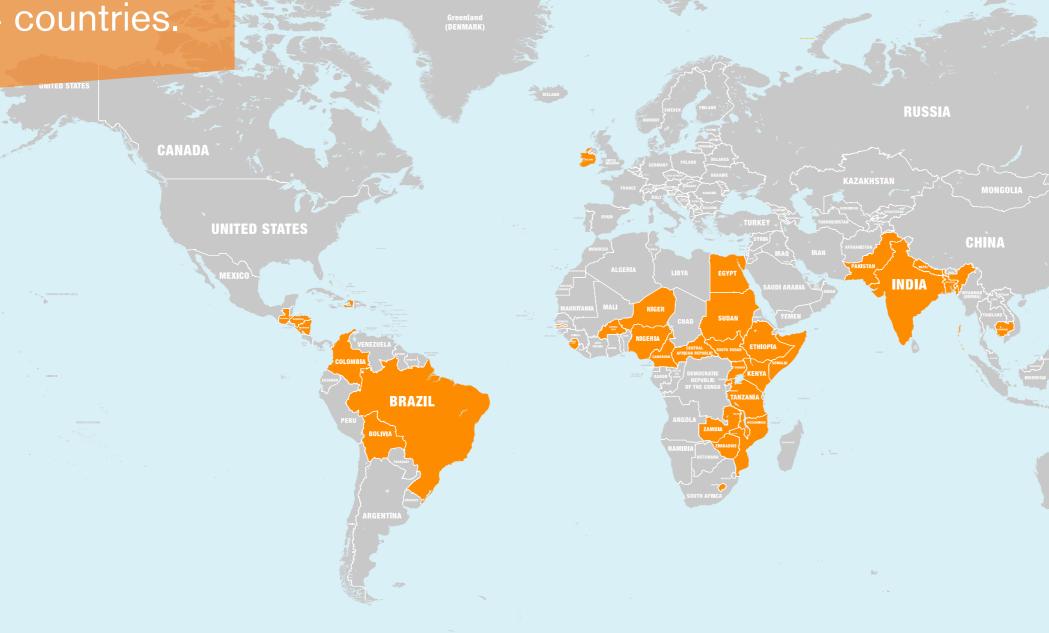

CHAIRPERSON'S REPORT

Welcome to ElectricAid's 2019 Annual Report.

It is with great pride that I chair ElectricAid, an organisation founded by ESB staff in response to the Ethiopian famine during the 1980s. It remains a charity of ESB and EirGrid serving and retired staff, whose generosity enables us to positively impact on thousands of lives in Ireland and across Africa, Asia, South and Middle America.

At a high level, our operating model is simple. Funds are collected from members, mostly at source through payroll, and distributed to partner organisations to fund projects aligned to the achievement of the United Nations Sustainable Development Goals or through emergency responses to humanitarian disasters. A strong governance framework and compliance to the Charity Governance Code ensures that ElectricAid operates with integrity and is managed in an effective, efficient, accountable and transparent way.

I see ElectricAid as being very strong on its engagement with partner organisations and management of funds going out, but the other side of the balance is our relationship with those who provide the funds, i.e. our members.

Members are central to our organisation, impassioned by the desire to aid the most vulnerable of communities. Recent years have seen a decline in our membership, reflecting what is occurring with our corporate partners, ESB and EirGrid.

In my note last year, I mentioned members of the Committee and Office attended The Bolder Board Training event with internationally renowned Dan Pallotta in November 2018. Pallotta encourages boards or committees to set big challenges, be bold in engaging members and supporters.

The Committee dedicated significant effort in 2019 in setting out a path for operational change that would bring members into better focus within our model.

How better to do this than to go and ask? It is time to gain better insights from our members & potential members, on their charity. A schedule of focus groups has been set out for early 2020 and I look forward to hearing feedback on how to achieve better engagement with our members, and how they in turn would like to be involved with their charity.

EXECUTIVE REPORT 2019

2019 proved to be another busy year in the administration of ElectricAid. Key highlights included an Emergency Appeal in response to the devastation caused by Cyclone Idai, our ongoing work to update CHY 3 forms for the Revenue Charitable donation Scheme, ongoing communication with our members, the ESB 5k Challenge and growing our membership.

ElectricAid Emergency Appeal

Cyclone Idai reached Mozambique in mid-March 2019 and went on to neighbouring Zimbabwe and Malawi. An estimated 3 million people were affected across the three countries and over 1,000 lives were sadly lost while many thousands more were left displaced and seeking shelter, food, access to clean water and proper sanitation.

By way of response, ElectricAid launched an Emergency Appeal for donations to support initial disaster relief efforts followed by longer term rebuilding programmes. ElectricAid responded with an immediate donation of €30,000 shared amongst GOAL, Oxfam, CBM (Christian Blind Mission), and Concern Worldwide who worked tirelessly on the ground to ensure that the most vulnerable communities had essential basics like food and shelter. This was followed by a further donation of €30,000 towards the reconstruction of classrooms and boreholes by both Trócaire and ActionAid. A heartfelt thanks to supporters, both serving and retired who quickly and generously donated to the Emergency Appeal.

Revenue Charitable Donation Scheme

An ongoing project throughout 2019 has been the renewal of CHY 3 forms for the Revenue Commissioners. As a registered charity, ElectricAid participates in the Revenue Charitable Donation Scheme which sees ElectricAid claim a rebate of up to 45% of a donor's annual contribution when they donate €250 or more. We can only claim this with your permission and when we hold a valid, signed CHY 3 form. These forms endure for a 5-year period and a significant number of these forms expired in 2019. We have made several appeals through the 2018 Annual Report, our ElectricAid website, the Hub and via post for members to return a signed form. Many thanks to over 1,200 eligible donors for taking time to return your forms and helping your donations go even further.

Communications

Communication with our members is vital, we do this via regular articles in Electric Mail, the ESB Staff Services website, the ElectricAid website and more recently via Yammer (ESB) and Buzz (EirGrid) one of our most important communications fixtures is our AGM which was held in ESB Head Office in May 2019 and presented an excellent opportunity to hear first-hand from Edith Wilkins of the Edith Wilkins Street Children Foundation, one of our long term charity partners working to providing care, shelter and protection to street children in Darjeeling, India.

A firm fixture of the ElectricAid calendar has been the ESB Athletic Club 5k Challenge held on the Clontarf seafront in Dublin. June saw just over 100 runners signing up and completing the run raising €2,150, further matched by ESB with €4,300 reaching ElectricAid

Finances

ElectricAid's income rests on three core sources. Donations from staff and pensioners of both ESB & EirGrid, our annual Revenue rebate and matched funding from ESB & EirGrid Our Revenue rebate fell compared to last year, due in part to CHY 3 forms expiring and not being renewed and due to no Emergency Appeal held in 2018. Membership stood at an average of 2,480 donors throughout 2019 which is a point of concern, however steps are underway to conduct detailed research in early 2020 via focus groups throughout ESB & EirGrid to ensure ElectricAid remains the charity of choice for staff and pensioners of both organisations. It is important to note, ElectricAid remains in a sound financial position and in 2019 extended funding to 123 projects across 34 countries.

A heartfelt and sincere Thank You to our donors, our Corporate partners, ESB & EirGrid and our charity partners worldwide. Together, we deliver life changing projects to make a lasting difference to some of the most marginalised, vulnerable and disadvantaged communities in the world.

COMMITTEE MEMBERS REPORT FOR THE YEAR ENDED 31 DECEMBER 2019

The Executive Committee present their annual members report for the year ended 31 December 2019.

The financial statements have been prepared in accordance with the accounting policies set out in note 2 to the financial statements and comply with the charity's constitution, the Charities Act 2009 and the Statement of Recommended Practice, applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102).

Objectives and Activities

The main object for which the charity is established is to raise money for the relief of want and to assist the needy at home and abroad, provided always that the income of the charity shall be applied solely for charitable purposes.

Structure, Governance and Management

The Executive Committee and the Trustees who held office during the financial year and at the date of this report are set out on the charity information page.

Trustees - Five Trustees shall control the funds of the charity and shall make the disbursements authorised by the Executive Committee.

Appointment as a Trustee shall be for a period of three years only and shall be renewable at the end of each such period. Officers or members of the Executive Committee shall not be eligible for appointment as Trustees. Two of the Trustees shall be elected at each third Annual General Meeting of the Scheme. The Chief Executive of the ESB shall nominate two Trustees as soon as practicable after the members have elected their two Trustees. The Chief Executive of EirGrid may nominate one Trustee as soon as practicable after the members have elected their Trustees.

An elected Trustee may retire by written resignation or shall automatically retire if required to do so by a decision of the members attending an Annual General Meeting or an Extraordinary General Meeting. The Chief Executive of the ESB may revoke the appointment of a nominated Trustee at any time. The remaining Trustees shall fill any casual vacancy arising among the elected Trustees by co-option of a member of the Scheme. A co-opted Trustee shall hold office for the remainder of the term of office of the Trustee being replaced. A casual vacancy among the nominated Trustees shall be filled by a person nominated by the Chief Executive of the ESB to hold office for the remainder of the term of office of the person being replaced.

The Trustee shall not be liable to make good any deficiency in the funds of the Scheme but shall be liable only for such sums of money as shall be actually received by them on account of the Scheme.

Executive Committee - Administration of the Scheme shall be carried out by the Executive Committee, which shall comprise: Honorary Officers, Chairperson, Vice-Chairperson, Honorary Secretary and Honorary Treasurer, elected by the members and at least six and not more than ten members elected by the membership at the AGM.

The Executive Committee shall meet as necessary for the administration of the Scheme but in any event the Executive Committee shall meet not less than four times per annum. A notice of the meeting and agenda shall be sent to every member of the committee. A quorum for every meeting shall be half of the committee members. In the absence of the Chairperson and Vice Chairperson one of the other committee members shall, by agreement, chair the meeting. For the purpose of voting at meetings all members shall have a vote and in the case of a tie the person chairing the meeting shall have a casting vote. Decisions taken at meetings will be on simple majority basis. Any vacancies that arise in the committee will be filled by co-opting by the committee. Such co-options may have regard to the executive election at the previous AGM. Requests for aid (with the exception of requests for emergency relief aid) must be submitted to the Honorary Secretary at least a week in advance of any meeting. Requests may be made by any recognized charitable organization or agency, or by a member of the Scheme on behalf of such organization or agency. For the purpose of advancing the objects of Electricaid, sub committees may be set up by the Executive Committee. The powers and rules of procedure of such sub committees will be at the discretion of the Executive Committee at all times.

Risk Management

The charity Executive Committee have considered the major risks to which the charity is exposed and have reviewed those risks and established systems and procedures to manage those risks.

Grant Making Policy

The Executive Committee shall authorise the disbursement of monies to such projects or agencies as are, in the opinion of the committee, consistent with the main object of the Scheme. Notwithstanding any other provision herein, emergency relief aid consistent with the main object of the Scheme may be disbursed without the necessity to hold a meeting of the Executive Committee provided that the prior agreement of half of the committee members (including the Treasurer and the Chairperson or in his or her absence the Vice Chairperson) is obtained thereto. A copy of each disbursement authorisation shall be provided to each of the Trustees.

Financial Review

The charity is reliant on the following sources of income, the ESB staff / pension payroll donations, EirGrid staff donations, the ESB board and the taxation rebate received from the Revenue Commissioners. Total income for 2019 was €1,077,590 compared to income of €1,181,225 in 2018. There was a deficit in the current year €59,144 (2018: surplus €120,402). As at 31 December 2019, the charity had reserves carried forward in the amount of €418,886 (2018: €478,030), of which €22,597 is restricted to the Ghana Sanitation project.

Investment Policy and Performance

The charity does not hold sufficient monetary reserves to generate additional income through investments. All monies are held in a current account controlled by the Trustees with the principal banker.

Reserves Policy

ElectricAid hold a general income & expenditure reserve balance of €396,289 as at 31 December 2019. This is to ensure, as far as is reasonably possible, that the charity's future expenditure objectives can be met, given certain assumptions made about future income streams. The 2019 Business Plan also identified a requirement that ElectricAid should maintain a capability of €50,000 for immediate emergency response in the event of a major humanitarian disaster. These funds would, if expended, be recouped from the proceeds of a Special Appeal.

Future Plans

While enormous progress has been made in achieving the Sustainable Development Goals (previously the Millennium Development Goals), the needs of the poorest and most disadvantaged around the world have never been greater. The ElectricAid Committee will continue to address poverty and development needs in the Developing World, social need in Ireland, and contribute to the relief of poverty and emergencies at home and abroad.

In the Developing World, we aim for long-term and environmentally sustainable improvement in the well-being of communities and we will continue to focus on micro-development projects in the areas of education, basic infrastructure and sanitation, health needs, food security, energy and micro enterprise. We will continue to promote awareness within the Electricity Supply Board and EirGrid of development issues. In partnership and support from our members, ESB and EirGrid, we plan to continue and strengthen our commitment to the struggle against global poverty and for sustainable development, world-wide.

Accounting records

The executive committee are aware of their responsibilities as to whether in their opinion, the accounting records of the charity are sufficient to permit the financial statements to be readily and properly audited and are discharging their responsibility by:

- implementation of necessary policies and procedures for recording transactions,
- employment of competent accounting personnel with appropriate expertise,
- the provision of adequate resources to the financial function.

The accounting records are held at the charity's premises, Gateway 2, Dublin 3.

Post reporting date events

At the time of authorising the financial statements for issue, the global economy has been severely impacted by the COVID-19 Global Pandemic. This is not expected to have a material impact on the charity generating income or carrying out its activities.

No other matters or circumstances have arisen since the end of the financial period which significantly affected or may significantly affect the operations of the charity.

Auditor

Moore continue in office as auditors of the charity.

The constitution of the charity requires the executive committee to prepare audited financial statements for the financial year which give a true and fair view of the charity's financial activities during the year and of its financial position at the end of the year. It is also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

INDEPENDENT AUDITOR'S REPORT FOR THE YEAR ENDED 31 DECEMBER 2019

Opinion

We have audited the financial statements of ElectricAid for the year ended 31 December 2019 which comprise the Statement of Financial Activities, the Balance Sheet, the Statement of Cash Flows and the related notes. The relevant financial reporting framework that has been applied in their preparation is FRS 102. The Financial Reporting Standard applicable in the UK and Republic of Ireland issued by the Financial Reporting Council.

In our opinion the financial statements:

- give a true and fair view of the assets, liabilities and financial position of the charity as at 31 December 2019 and of its deficit for the year then ended;
- have been properly prepared in accordance with FRS 102 The Financial Reporting Standard applicable in the UK and Republic of Ireland; and

Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (Ireland) (ISAs (Ireland)) and applicable law. Our responsibilities under those standards are further described in the Auditor's responsibilities for the audit of the financial statements section of our report. We are independent of the charity in accordance with the ethical requirements that are relevant to our audit of financial statements in Ireland, including the Ethical Standard issued by the Irish Auditing and Accounting Supervisory Authority (IAASA), and we have fulfilled our other ethical responsibilities in accordance with these requirements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Conclusions relating to going concern

We have nothing to report in respect of the following matters in relation to which the ISAs (Ireland) require us to report to you where:

- the executive members use of the going concern basis of accounting in the preparation of the financial statements is not appropriate; or
- the executive members have not disclosed in the financial statements any identified material uncertainties that may cast significant doubt about the charity's ability to continue to adopt the going concern basis of accounting for a period of at least twelve months from the date when the financial statements are authorised for issue.

- accounting records are sufficient to audit and agree with financial statements.

In preparing the financial statements, the executive committee are responsible for assessing the charity's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the executive committee either intend to liquidate the charity or to cease operations, or have no realistic alternative but to do so.

Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

1 General Information

Charity information

ElectricAid is registered charity domiciled in Ireland with charity registration number 20045821. The registered office and its place of operation is Gateway 2, Dublin 3.

Statement of Compliance

These financial statements have been prepared in accordance with FRS102 'The Financial Statement Reporting Standard applicable in the UK and Republic of Ireland'.

Currency

The financial statements are prepared in euros, which is the functional currency of the charity. Monetary amounts in these financial statements are rounded to the nearest \in .

2 Accounting policies

2.1 Basis of preparation

The financial statements have been prepared in accordance with the charity's constitution, the Charities Act 2009 and the Statement of Recommended Practice applicable to charities preparing their accounts in accordance with FRS 102 applicable in the UK and Republic of Ireland.

The audited financial statements are prepared under the historical cost convention and in accordance with applicable accounting standards.

2.2 Going concern

The financial statements have been prepared on a going concern basis. Further detail is included in Note 4.

2.3 Funding accounting

Unrestricted funds are general funds that are available for use at the executive committees' discretion in furtherance of the objectives of the charity.

Designated funds are unrestricted funds set aside at the discretion of the executive committees for specific purposes. The designated fund for fixed assets is that part of unrestricted funds that represents fixed assets held.

Restricted funds are those donated for use in a particular area or for specific purposes, the use of which is restricted to that area or purpose.

2.4 Donations and legacies

Voluntary income, including donations, gifts and legacies and grants that provide core funding or are of a general nature, are recognised once the charity has entitlement to the resources, it is certain that the resources will be received and the monetary value of incoming resources can be measured with sufficient reliability.

2.5 Expenditure on charitable activities

Expenditure is recognised as resources expended as soon as there is a legal or constructive obligation committing the charity to the expenditure. All expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category.

Costs of generating funds are those costs incurred in attracting voluntary income, and those incurred in trading activities that raise funds.

Governance costs include those incurred in the governance of its assets and are primarily associated with constitutional and statutory requirements.

2.6 Income

The total income of the charity for the year represents donations received from employees/pensioners from ESB/EirGrid. ESB/EirGrid also commit to a capped matching fund on an annual basis depending on the donations of their employees/pensioners. All income arises within the state.

2.7 Taxation

As a result of the charity status, no charge to corporation tax arises under the provision of Section 207 and 208 of the Taxes Consolidation Act 1997. ElectricAid is compliant with relevant tax circulars including circular 44/2006 "Tax Clearance Procedures Grants Subsidies and Similar Type Payments".

3 Judgements and key sources of estimation uncertainty

In the application of the charities accounting policies, the members of committee are required to make judgements, estimates and assumptions about the carrying amount of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised where the revision affects only that period, or in the period of the revision and future periods where the revision affects both current and future periods.

Critical judgements

The members of committee are of the view that there are no judgements (apart from those involving estimates) in applying their accounting policies that have had a significant effect on amounts recognised in the financial statements.

Key sources of estimation uncertainty

The members of committee are of the view that there are no estimates or assumptions which have a significant risk of causing a material adjustment to the carrying amount of assets and liabilities.

4 Going concern

At the time of authorising the financial statements for issue, the global economy has been severely impacted by the COVID-19 Global Pandemic. This is not expected to have a material impact on the charity generating income or carrying out its activities.

The committee members were of the view at the time of authorising the financial statements for issue that it had adequate resources to withstand the impact of the COVID-19 Pandemic on its operations and as such the financial statements have been prepared on the going concern basis.
